Board Education Session – CMHA WW Children's Services & The Grove	<ul> <li>Krista Sibbilin and Jeff Hoffman presented on CMHA WW Children's Services and The Grove.</li> <li>Highlights <ul> <li>CMHA WW supports the infrastructure of The Grove; this has allowed the youth hubs to get up and running quickly, and also facilitates access to services between The Grove and CMHA WW Children's Services.</li> <li>We have developed an Integrated medical team between CMHA WW and The Grove (NP, RPN, Psychiatrist, Children's Psychiatric Nurse), which will also support youth and transitional aged youth who do not have a family physician.</li> <li>We are working with Guelph General Hospital on patient flow and have worked with Grand River Hospital to ensure CMHA WW clinician access on the Child &amp; Adolescent Inpatient (CAIP) unit.</li> </ul> </li> </ul>
